I freely and voluntarily agree to assume all physical and legal risks that may arise from my participation in this event. I further state that I am in proper physical condition to participate in this event.

WAIVER, RELEASE AND INDEMNIFICATION:

In consideration of the Kamloops Invitational Soccer Tournament Society allowing me to participate in this event, I, for my heirs, executors, administrators, and assigns, release the Organizing Committee, the Kamloops Recreational Soccer League, the Kamloops Women's Soccer League, Kamloops Soccer Referees Association, the Kamloops Senior Men's Soccer League, City of Kamloops and Recreation District, the tournament directors, organizers, sponsors, officials, and all other organizations, corporations or persons connected with the event or related activities, and their respective officers, directors, representatives, servants, agents, employees, and volunteers (herein referred to as the "Event Organization") and do hereby waive as against the Event Organization all recourse, claims, demands, damages, actions or causes of action arising out of or in consequence of my death or any loss, injury, or damage to my person or property which I may suffer arising out of or in connection with my participation in this event or any related activity, whether prior to, during or subsequent to the event, however caused, and even if such death, loss, injury or damage may have been contributed to or occasioned by the negligence of the Event Organization, other athletes, officials, participants, spectators, or any other persons that I may encounter as a result of my participation in this event or related activities.
